This is detailed in Advanced Diploma of Human Resource ACSF Profile.</li><li>• See the student and learning support policy</li></ul> <p><b>English Language Requirements</b></p> <p>All students entering this qualification must have the following minimum score of an internationally recognized English Language proficiency tests or equivalent.</p> <ul style="list-style-type: none"><li>• IELTS overall band of 5.5 or</li><li>• TOEFL IBT test score band of 54-56 equivalents or</li><li>• PTE Academic band score 42 equivalent or</li><li>• Satisfactory completion of General English – Upper intermediate level or</li><li>• Successful completion of Certificate III in Spoken and Written English (10725NAT) or equivalent course or</li><li>• Successful completion of Senior Secondary certificate of education in Australia conducted in English or</li><li>• Completion of full-time studies in Australia towards a Certificate IV or above or a foundation course or</li><li>• Student's first language is English or</li><li>• Student was educated for 5 years in an English-speaking country.</li></ul> <p>If there are doubts about the student's English language skills to cope in an academic environment and if he/she cannot provide a satisfactory IELTS score or equivalent, the student will undergo the college English placement test and be required to complete it with a satisfactory result.</p>

<b>Reasonable adjustment</b>	<p>Students who have special needs such as physical or mental impairment will be assisted through the learning via training and assessment resources. Reasonable adjustment will be applied and recorded on the assessment resources.</p>
<b>Training Arrangements</b>	<p>Class sessions are planned to ensure that you have a mixture of practical and theoretical components and those classes cater for a wide variety of learning styles. Additionally, workplace practices and environments will be regularly simulated and used to conduct skills-based assessments in accordance with unit requirements.</p> <p>Students must attend 20 hours per week in the classroom</p> <p>Homework tasks may include research, readings from related course material and continuing to work on assessment tasks.</p> <p>Students are provided with a variety of course materials, including student assessments that comprise both knowledge and skill evaluations, learner guides, PowerPoint presentations, self-study guides, session plans, and various class activities. The classroom setting ensures that students have full access to the internet, whiteboards, and the support of a trainer and assessor, creating a comprehensive and supportive learning environment.</p>
<b>Additional Support</b>	<p>All students will complete a language literacy and numeracy assessment upon enrolment to determine their learning support needs. All students will be provided with a range of learning support options and resources to help you achieve competency. Where additional support needs have been identified an <i>Individual Support Plan</i> will be developed which may include:</p> <ul style="list-style-type: none"><li>• Mentoring from trainers</li><li>• Additional classes, tutorials and workshops</li><li>• Online support and exercises for some courses</li><li>• Computer and technology support</li><li>• Referral to external support services</li><li>• Reasonable adjustment to assessments</li></ul> <p>Provision of additional support services will be provided where necessary to enable students to participate in the same way as any other person regardless of whether support services have been required.</p>
<b>Assessment Arrangements</b>	<p>Assessment will be conducted individually/in groups. <b>Course Credit</b>	<p>SHIC can grant you credit towards your course for units of competency that you have already completed with another RTO or authorised issuing organisation. We can also grant you Credit for subjects or units you have completed where equivalence can be established between the unit in your course, and the subject or unit you have completed.</p> <p>There is no charge to apply for Credit.</p> <p>To apply, fill in the Credit Application Form and submit it as part of your enrolment.</p> <p>*Please refer to your Student Handbook for more information on Course Credit. <b>Recognition of Prior Learning (RPL)</b>	<p>Recognition of Prior Learning (RPL) is a process where skills and knowledge that you have gained through work and life experience and other unrecognised training can be formally recognised.</p> <p>SHIC has a process that has been structured to minimise the time and cost to applicants and provides a supportive approach to students wishing to take up this option. You should ideally apply for RPL at the time of enrolment but you may also apply up to 2 weeks into your course.</p> <p>During the entry process and interview stage SHIC will discuss with you the process and options for RPL. Suitability is often determined on how much experience you have in a certain area, your work history and previous training. If RPL is determined as a possibility for you, you will be provided with a kit that will guide you in working through each unit to determine relevant skills and experience and identify whether you would be able to provide the required evidence.</p> <p>A trainer/assessor will be available to assist you throughout this process.</p> <p>*Please refer to your Student Handbook for more information on RPL.
