<b>Entry Requirements</b>	<p><b>Age Requirements</b></p> <p>Sacred Heart International College requires that all students must be 18 years of age or above at the commencement of course.</p> <p><b>Prior Achievement Requirements:</b></p> <p>There is no specific entry requirements mandated for this qualification as per training.gov.au.</p> <p><b>LLN Requirements</b></p> <ul style="list-style-type: none"><li>• The qualification has been analysed against the skill level requirements of the Australian Core Skills Framework (ACSF) and recorded in the CPC31320 Certificate III in Wall and Floor Tiling ACSF Profile. Students entering this qualification will have their LLN skills compared to the ACSF levels of the course to determine if there are specific support requirements needed and make a recommendation about the suitability of the student to enroll.</li><li>• The qualification has been analysed to determine the Australian Core Skills Framework (ACSF) levels of Learning, Reading, Writing, Oral Communication and Numeracy. 	<p>student will undergo the college English placement test and be required to complete it with a satisfactory result.</p> <p><b>Additional Requirements</b></p> <p>Students are required to have physical capacity and adequate balance to safely meet the demands of training and assessment activities, including working at heights, undertaking heavy lifting and manual labour, and operating both hand and power tools.</p>
<b>Holiday Breaks/ Course Calendar</b>	<ul style="list-style-type: none"><li>• Course Calendars which detail the start and end dates of Course/s, Units, Holiday Breaks are advised at the time of enrolment in the form of course calendar for the starting course.</li><li>• It is further confirmed and explained at the time of student induction and at the start of the course by the trainer.</li><li>• Calendars are also displayed on the noticeboard and in the classroom</li><li>• It can be also requested by the students from their trainers and student support at any time in between the duration of their respective course/s.</li></ul> <p>SHIC has rolling calendars and have multiple start dates for the convenience of students to accommodate students in packaged courses in order to have minimum study gaps between the courses.</p>
<b>Monitoring Course Progress</b>	<p>SHIC monitors the academic progress of all students in line with its <i>Monitoring International Student Academic Progress Procedure</i>. A term is defined as 10 study weeks, and students must achieve competency in at least 50% of the units undertaken in each term.</p> <p>Academic progress is reviewed on a regular basis, and students are advised early if their results indicate they are at risk. Where a student's progress falls below 50% in a term, a formal warning letter is issued and an intervention plan is implemented.</p> <p>If progress does not improve in the following term, a second warning is issued. Students who remain below 50% for two consecutive terms will receive a breach notice and may be reported to the Department of Home Affairs.</p> <p>Before any report is made, students are informed of their right to access the complaints and appeals process.</p>
<b>Reasonable adjustment</b>	<p>Students who have special needs such as physical or mental impairment will be assisted through the learning via training and assessment resources. Reasonable adjustments will be applied and recorded on the assessment resources.</p>
<b>Training Arrangements</b>	<p>Class sessions are planned to ensure that you have a mixture of practical and theoretical components, and those classes cater for a wide variety of learning styles. Additionally, workplace practices and environments will be regularly simulated and used to conduct skills-based assessments in accordance with unit requirements.</p> <p>Students must attend 20 hours per week in the classroom, including practical training and assessment at the workshop to complete the requirements of the units.</p> <p>Homework tasks may include research, readings from related course material and continuing to work on assessment tasks.</p> <p>Students are provided with a variety of course materials, including student assessments that comprise both knowledge and skill evaluations, learner guides,</p>

	<p>PowerPoint presentations, self-study guides, session plans, and various class activities. The classroom setting ensures that students have full access to the internet, whiteboards, and the support of a trainer and assessor, creating a comprehensive and supportive learning environment.</p>
<b>Additional Support</b>	<p>All students will complete a language literacy and numeracy assessment upon enrolment to determine their learning support needs. All students will be provided with a range of learning support options and resources to help you achieve competency. <b>Assessment Arrangements</b>	<p>Assessment will be conducted individually/in groups. You will be provided with a Student Assessment Booklet for each unit of competency which includes:</p> <ul style="list-style-type: none"><li>• A full description of all assessment tasks for the unit of competency</li><li>• Assessment instructions for each unit of competency</li><li>• Assessment resources for each unit of competency</li><li>• Details about when assessment will occur</li><li>• Details about assessment submission</li></ul> <p>There are a variety of assessment methods used for this qualification including:</p> <ul style="list-style-type: none"><li>• Written questions</li><li>• Projects</li><li>• Case studies</li><li>• Role Plays</li><li>• Research</li><li>• Reports</li></ul> <p>Students will be required to complete assessments both in class and in their own time. Trainers and assessors will provide detailed assessment requirements for each unit at the beginning of the delivery for that unit. Students will follow the assessor's instructions for submitting assessment tasks</p>
<b>Course Credit</b>	<p>SHIC can grant you credit towards your course for units of competency that you have already completed with another RTO or authorised issuing organisation. <p><b>Recognition of Prior Learning (RPL)</b></p>	<p>Recognition of Prior Learning (RPL) is a process where skills and knowledge that you have gained through work and life experience and other unrecognised training can be formally recognised.</p> <p>SHIC has a process that has been structured to minimise the time and cost to applicants and provides a supportive approach to students wishing to take up this option. You should ideally apply for RPL at the time of enrolment, but you may also apply up to 2 weeks into your course.</p> <p>During the entry process and interview stage SHIC will discuss with you the process and options for RPL. Suitability is often determined on how much experience you have in a certain area, your work history and previous training. If RPL is determined as a possibility for you, you will be provided with a kit that will guide you in working through each unit to determine relevant skills and experience and identify whether you would be able to provide the required evidence.</p> <p>A trainer/assessor will be available to assist you throughout this process.</p> <p>*Please refer to your Student Handbook for more information on RPL. <b>Selection Process</b>	<p>You will be required to complete a language, literacy and numeracy (LLN) assessment prior to finalising your enrolment to ensure that the course is suitable for you and that SHIC is able to meet your individual needs. The assessment includes a written test and an interview to complete the verbal component of the test.</p> <p>If you do not achieve the required level in your LLN assessment SHIC will (where possible) provide student support measures. Where this is not possible your enrolment application will not be accepted in this instance and you will be referred to an appropriate external services or courses. You may reapply in the future once you have undertaken further language, literacy and numeracy skills training.</p>
