Monitoring Course Progress	At the end of each study period students will be assessed as having met or not met the course progress requirements. At the end of each monitoring period students will be assessed for being at risk of not meeting course progress requirements, and an individual intervention plan will be implemented so that SHIC can support those who are 'at risk'. This course consists of 4 study periods or "Terms" of 11-14 weeks each. Without counting holiday weeks this is a total of 52 weeks. Each of these study periods is broken to form monitoring periods, therefore course progress is monitored.
	Reasonable adjustment:
	Students who have special needs such as physical or mental impairment will be assisted through the learning via training and assessment resources. Reasonable adjustment will be applied and recorded on the assessment resources.
Training Arrangements	Class sessions are planned to ensure that you have a mixture of practical and theoretical components and those classes cater for a wide variety of learning styles. Additionally, workplace practices and environments will be regularly simulated and used to conduct skills-based assessments in accordance with unit requirements.
